Subject to the following terms and conditions, Sun Tran hereby assigns:

1. TERM AND PAYMENT: This Bicycle Locker ("Agreement") shall be for a term of six months at a charge of \$5.00 per month beginning on _____ and ending on _____. The sum of \$30.00 shall be due and payable upon commencement of the rental term.

This Agreement may be renewed for successive six-month terms unless otherwise terminated by Sun Tran. Renewal of the rental of the bicycle locker by payment of rent shall constitute renewal of this Agreement. There will be no prorated refund if the renter terminates this agreement before the six-month term is completed.

If any payment of the bicycle locker fee is due, here under, and is not made within thirty days, Sun Tran may, at its option, recover possession of the locker and dispose of any property remaining in the bicycle locker, and/or terminate this agreement.

2. PURPOSE AND CONTENT OF LOCKER: Bike locker is for the intended purpose of storing Renter's bicycle, and for storing any other related items (i.e. helmet, backpack, change of clothes, etc). Renter is specifically prohibited from storing any illegal articles and combustible and/or explosive devices in the bicycle locker. Violation of the foregoing may result in the immediate termination of this agreement, forfeiture of any remaining prepaid rent, seizure of any property contained in said locker and possible prosecution.

3. RIGHTS OF CANCELLATION: Sun Tran reserves the right to cancel this Agreement at any time upon giving the renter 30 days written notice and refunding any remaining full month's rental. Refunds shall be made only by check and require 30 calendar days to process.

4. LOCK: Renter is responsible for purchasing and maintaining a lock on the bicycle locker during the term of this Agreement.

5. RIGHTS OF INSPECTION: Sun Tran reserves the right to inspect the bicycle locker at any time. Renter's signature on this Agreement constitutes Renter's advance written permission for Sun Tran or any law enforcement officer to conduct any such inspection. In the event that Renter fails to comply with an inspection request upon reasonable notification by Sun Tran, the cost of replacement of any bicycle locker locking device which is destroyed in the process of inspecting the bicycle locker, shall be borne by the Renter.

6. LIABILITY: Sun Tran is not responsible for fire, theft, loss, or damage to the contents of the bicycle locker. Renter is responsible for securing the bicycle locker and its contents at all times.

7. ABANDONED PROPERTY: Any equipment left in the bicycle locker following the termination of this Agreement shall be considered abandoned property and will be disposed of in accordance with the City of Tucson Code pertaining to lost and abandoned property.

8. CONTACT INFORMATION: A current address and telephone number where Renter can be contacted must be provided. It is the responsibility of the Renter to inform Sun Tran of any change of address or telephone number within ten business days. Any failure to comply with this requirement may result in immediate termination of this Agreement.
