Eligibility Criteria: the applicant must be 65 years of age or older. Approved applications enable seniors to pay the reduced fare on Sun Tran and Sun Shuttle.

How to Apply Checklist:

- Please provide one of the following valid photo IDs:
 - Driver's license
 - State ID card
 - Passport
 - Government-issued ID
 - Tribal Identification with date of birth
- Please provide one of the following documents as proof of age:
 - Valid driver's license
 - Passport
 - Government-issued ID with date of birth
 - Medicare Card
 - Tribal Identification with date of birth

To qualify as a senior citizen, the applicant must be 65 years of age or older. Please provide one of the following documents as proof of age to qualify for a senior ID card. Check which document you are providing.

I understand that my application will be denied if the information provided is found to be untrue. The signature below certifies that all information relative to eligibility is correct. In accordance with the Tucson City Code (Sec. 2-22.1) any person providing false information or refusal to provide information is punishable by a \$500 fine and may be deemed ineligible for the economy fare for up to five (5) years.
