Item One: QUESTION:

Long and short sleeve reflective white shirts are specified. Can additional details be provided?

ANSWER:

On the price page (Attachment A), item 11 LG SLEEVE REFLECTIVE WHITE SHIRT (WITH LOGO) and item 12 SHRT SLEEVE REFLECTIVE WHITE SHIRT (WITH LOGO) are no longer available as originally specified.
